MINUTES

Minutes of the Board meeting of June 12, 2009 regular meeting were approved as written. (Harf/Unanimous)

Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously.

ADMINISTRATION

Board members reviewed the financial report from the last Quarter and the proposed budget for FY 2011. The members noted that the funds for the allied health recovery program, which had not been used for three years, were dropped from the budget planning, and that the elimination of the Occupational Therapy Board revenues and costs were reflected in the budget. The Board acted to approve the FY 2011 budget as presented. (Jackson/Unanimous)

David McClusky, II, MD, gave a brief review of the Idaho Medical Association (IMA) annual meeting.

Laura McGeorge, MD, volunteered to write the newsletter article for the fall newsletter.

The Executive Director provided a brief overview of the use of the Federation of State Medical Boards (FSMB) uniform application, including ease of data transfer and cost savings. The Board acted to approve the staff request that paper applications be eliminated for physicians in January 2010, and on-line application development for all professions licensed by the Board be implemented as soon as feasible. (Bennett/Unanimous)

Members reviewed the information provided on the license endorsement option ; there have been 52 licenses issued by endorsement since May 2009. (Information)

The Board acted to approve travel for the Executive Director to attend the East and West Administrators in Medicine (AIM) Regional Conferences, the AIM Institute, and the Joint AIM and FSMB Executive Institute. It was noted that full or partial funding will be provided by AIM or FSMB for most conferences. (Harf/Unanimous)

Following review and discussion the members acted to approve the records retention policy modification that eliminates the requirement for retention of non-essential emails. (Jackson/Unanimous)

Board members reviewed the quarterly report of the Physician Recovery Network.

The members acted to set the 2010 meeting calendar dates for March 5, June 4, September 10 and December 3, 2010. (Harf/Unanimous)

The Board reviewed the draft discipline standard table, and agreed that the table may be a useful tool for reference but would not enhance the Idaho Board of Medicine mission of public protection. (Consensus)

LEGAL

Board members reviewed the proposed statutory changes to §54-1806 and §54-1807, Idaho Code, and directed staff to continue the legislative process.

The Board reviewed the proposed changes to the Rules of the Board of Medicine for the Licensure to Practice Medicine and Surgery and Osteopathic Medicine and Surgery in Idaho, IDAPA 22.01.01., and suggested changes to clarify the language related to investigation and directed staff to continue the rule promulgation process with the proposed changes. (McRoberts/Unanimous)

LICENSURE

In accordance with Idaho Code §67-2345 (b), (d) and (f), the Board moved to go into Executive Session at 12:40 p.m. (Motion Harf – Affirmed, Bennett, Cone, Ganz, Jackson, McClusky, McGeorge, McRoberts, Russell, and Sutherlin)

In executive session, the Board conducted interviews of applicants for licensure.

The Board acted to leave Executive Session at 3:01 p.m. (Motion Cone – Affirmed, Bennett, Ganz, Harf, Jackson, McClusky, McGeorge, McRoberts, Russell, and Sutherlin)

The Board acted to grant licensure and impose an administrative fine for false and or incorrect responses on application for applicant BOMA-2584. (McRoberts/Motion passed)

The Board acted to require SPEX examination for applicant BOMA-2670. (Ganz/Unanimous)

Applicant BOMA-2416 failed to appear for the scheduled interview.

The Board acted to grant full unrestricted licensure to applicant BOMA-2651. (Bennett/Unanimous)

The Board acted to grant full unrestricted licensure to applicant BOMA-2638. (McRoberts/Unanimous)

The Board acted to grant a limited license to applicant for reinstatement BOMA-2054. (Bennett/Unanimous) (Harf recused)

The Board considered Case Number 6372, alleging the unlicensed practice of medicine, and directed staff to issue a cease and desist letter, as well as to pursue injunctive relief if practice continues. (Jackson/Unanimous)

The Board reviewed minutes of the August 24, 2009 meeting of the Physician Assistant Advisory Committee.

The members congratulated Jean Uranga for her recognition as one of the top 40 female attorneys in the Mountain States Super Lawyers 2009 publication, and her recognition as a trailblazer for being one of the first female attorneys in Idaho.

The Executive Director gave a brief overview of Maintenance of Licensure (MOL) activities and her appointment to FSMB MOL advisory committee.
